SHELF LIFE AND STORAGE

Shelf life will be one year from the date of manufacture as long as containers remain unopened and when material is store in a protected environment that is free from moisture, excessive heat and freezing temperatures, and direct sunlight.

WHERE TO USE

MiraPrime 500 is primarily used to seal new or existing plywood or concrete surfaces prior to the application of Miracote polyurethane waterproofing and surfacing systems or to prime existing polyurethane surfaces to recoat. A special feature of MiraPrime 500 is it's extremely low odor and freedom from toxic effect on applicators or personnel in the area. MiraPrime 500 is ideal for use on pedestrian traffic decks and balconies, parking decks, etc.

FOR BEST RESULTS

Install a minimum 4' by 4' test area site mock up for approval of acceptable color, texture, finish, adhesion, and any other critical requirement acceptable to the owner prior to proceeding with the installation.

Verify current versions of product technical data sheets (PTDS), material safety data sheets (MSDS), and installation guides (IG) at <u>www.miracote.com</u>.

Protect materials from excessive heat and cold and regularly check wet film thickness with mil gauge and monitor consumption to ensure correct application thicknesses and rate are obtained.

OVERVIEW OF INSTALLATION STEPS

- Prepare concrete surfaces by shot blasting or acid-etching. Metal surfaces must be cleaned of all paint, grease, rust, and scale, by chipping, power brushing or sandblasting.
- Mix resin and hardener components thoroughly.
- Apply MiraPrime 500 by trowel, roller or squeegee.

• Apply additional coat of MiraPrime 500 over areas where high water tables are present or if first coat is totally absorbed.

Cautions: Clean all equipment immediately after use with water. Do not take internally. KEEP FROM FREEZING. For industrial use and professional application only.
